Wireless Magnetic Contact Transmitter



Installation Instructions

1. INTRODUCTION

The WT-301 is a miniature, wireless, magnetic contact transmitter which can be employed in virtually all applications where an ordinary magnetic contact is normally used.

The WT-301 can be installed on doors, windows and other openings. It can also be flush mounted onto wood or PVC window frames and other surfaces.

Thanks to its slimness and low profile design, the WT-301 can also be completely concealed within the cavity of some PVC window frames.

The opening of a door, window, etc. will trigger the WT-301 into operation, transmitting for approximately 2 seconds to the receiver.




Figure 1. WT-301 - Internal View

2. SPECIFICATIONS

Encoding: 8-bit - 256 combinations, pulse width modulation.

Channels: 4 channels - switch selectable.

Frequency (MHz): 315, 404, 418 and 433.92 or other

frequencies according to local requirements. **Transmission Time:** Approximately 2 seconds.

Power Supply: 12 Volt alkaline battery (Duracell MN-21, Golden

power GP-23A or equivalent).

Note: Transmitter characteristics may be affected by battery condition.

Operating Temperatures: 0° to 49°C (32° to 120°F).

Dimensions: 87 x 25.5 x 15 mm (3.4 x 1.0 x 0.57 in.).

Weight (excluding battery): 25.5 g (0.8 oz).

Color: White.

Compliance with Standards:

Meets the requirements of FCC Part 15, MPT 1340, ETS 300 220,

ETS 300 339 and ETS 300 683.

The 418 and 433.92 models of this device comply with the European Council Directive EMC 89/336/EEC & 92/31/EEC and

bear the CE mark and certification.

3. INSTALLATION

3.1 Coding




Figure 2. Code Selector

A. The WT-301 has an eight-key DIP switch (marked 1 to 8). Each switch may be set to ON or OFF position, to create a unique digital system code - see Figures 1 and 2.

B. Use a ball point pen to set each of the switches to match the code setting of the companion receiver. All wireless PIR detectors, transmitters and the receiver in the system must be set to the same digital code.

CAUTION: The code combination 2, 4, 5, 6, 7 ON - 1, 3, 8 OFF is a factory test code and must not be used. Also avoid codes which are often used: all keys ON, all keys OFF or alternating ON-OFF settings.

3.2 Channel Selection

The WT-301 is a multi-channel transmitter. Each transmitter can be set (using the channel selector) to transmit one of the four different messages (channels) on the same system code, to activate different outputs at the receiver.

This feature is very useful for zoning purposes, activating instant and delayed zones at the control panel, etc. The channel selector consists of a 4 key DIP-switch marked "CHAN".

The channel on which the WT-301 will transmit is selected by switching the corresponding channel key to "ON" (fig. 3). Use a ball point pen to set the channel selector.

3.3 Battery Installation

The WT-301 is powered by a 12 Volt Alkaline battery (Duracell MN-21, Golden Power GP23A or equivalent).

The battery should be inserted between the two battery clips so that the (+) and (-) markings on the battery are in the same direction as the markings on the P.C. board (close to each battery clip). Check that the battery is held securely by the battery clips.

Separate magnet and transmitter. Verify that the WT-301 activates the receiver output.

IMPORTANT: The WT-301 does not include a built-in battery test or supervision capabilities. It is therefore required that the operation of the WT-301 be tested at least once a week.

Although the Alkaline batteries mentioned above should last more than 24 months (in standby), a battery change is recommended at 12 month intervals. If the WT-301 is triggered more than 5 times per day, it may be necessary to change the battery more frequently.

3.4 Mounting




Figure 4. Surface Mounting

A. Surface mounting (see Figure 4):

Install the transmitter and magnet as shown. Be careful to install the magnet not more than 6 mm (0.25 in.) from the "marked" side of the transmitter.

Note: Transmitter and magnet positions, relative to each other, offer a broad range of installation possibilities.

B. Flush mounting (see Figure 5)

- 1. Prepare an opening for the transmitter: 65 x 25.5 mm (2.56 x 1")
- 2. Install the transmitter into the prepared opening.
- 3. Place the inner cover on the transmitter.

- **4.** Secure the transmitter in place with two screws.
- 5. Snap the outer cover onto the transmitter assembly.
- 6. Install the magnet. Make certain that the magnet is positioned next to the marked side of the transmitter case and not more than 6 mm (0.25 in) from it.

C. Concealed Installation

Notes: Because conditions may vary, the following are presented as basic, general instructions:

- Not all window frames are suitable for concealed installation.
 The most suitable are PVC and wooden frames.
- DO NOT install inside metal windows.
- 1. Prepare the cavity for transmitter installation.
- 2. Install the transmitter.
- Install the magnet. Make certain that the magnet is installed next to the marked side of the transmitter case and not more than 6 mm (0.25 in.) from it.

3.5 Testing

- A. Activate the transmitter by separating the transmitter and magnet (open door, slide window etc.)
- B. Verify that the WT-301 activates the channel output relay(s) at the receiver which corresponds to the setting of the WT-301 'CHAN' switch(es).

4. PRODUCT LIMITATIONS

NOTES: Visonic Ltd.'s wireless systems are very reliable and are tested to high standards. However, due to their low transmitting power (required by FCC regulations) there are some limitations to be considered.

- A. Receivers may be blocked by radio signals occurring on or near their operating frequencies regardless of the code selected.
- **B.** A receiver can only respond to one transmitter signal at a time.
- C. Wireless equipment should be tested regularly (at least once a week) to determine if there are sources of interference and to protect against faults.
- **D. Warning:** Changes or modifications to this unit not expressly approved by the party responsible for compliance could void the user's authority to operate the equipment.

WARRANTY
